## SPECIAL MEETING BOARD OF EDUCATION

August 30, 2007 Seminar Room

**STUDY/DIALOGUE SESSION:** At 4:37 p.m., the Board met in its entirety – Jane Barnes, President; Vince Chowdhury, First Vice President; Sue Marinelli, Second Vice President; Scott Benefield, Secretary; and, Hereford Percy, Treasurer – in study/dialogue session in the Seminar Room, Education Center, Golden, Colorado. Cynthia Stevenson, Superintendent, represented the administration. A break was taken from 6:03 p.m. to 6:13 p.m. Trainers from BoardDocs were also present.

**PURPOSE:** For the Board of Education and Superintendent to be trained in the use and functionality of the BoardDocs egovernance system for Jeffco Public Schools.

**DISCUSSION:** Board discussion covered application examples related to Board agendas, notetaking, policies, searches, and news items.

**CONCLUSION:** The Board of Education will work toward online, paperless agenda processes for the current and future school years.

**STUDY/DIALOGUE SESSION:** At 6:13 p.m., the Board met in study/dialogue session in the Seminar Room.

**PURPOSE:** For the Board of Education to receive information from the superintendent regarding future elections.

**DISCUSSION:** The superintendent presented information related to long term strategies for elections supporting the work of Jeffco Public Schools. Future elections may include mill levy override, bond election, transportation or technology mill levies. Issues discussed included Jeffco's operational and construction management of current funds; teacher pay; informed community involvement, and the district's performance on 1999 "Performance Promise" mill levy.
