## SPECIAL MEETING BOARD OF EDUCATION

January 20, 2009 Seminar Room

**CALL TO ORDER:** A special meeting was called to order by Scott Benefield, President of the Board of Education at 8:11 a.m. in the Seminar Room of the Education Center, 1829 Denver West Drive, Golden, Colorado.

**ROLL CALL:** Roll call indicated that a majority of the Board – Scott Benefield, President; Jane Barnes, First Vice President; and, Sue Marinelli, Secretary – met for a special meeting. Dave Thomas, Second Vice President, and Rick Rush, Treasurer, were excused. Cynthia Stevenson, Superintendent, represented the administration.

## **LEGISLATIVE ACTION:**

**LEGISLATIVE UPDATE (EL-17, COMMUNICATION AND COUNSEL TO THE BOARD):** Ed Bowditch, the district's contract lobbyist, presented an update on the state budget's current \$631 million shortfall and projections for next year. Mr. Bowditch and members of the school district staff summarized proposed legislation and discussed it with the Board.

MOTION #1 (<u>Take Positions on Legislation</u>): Upon motion by Ms. Marinelli, seconded by Ms. Barnes, the Board took positions: to support HB09-1065, Educator Identifier Pilot Program; SB09-32, UNC Education Innovation Institute; 62, Veteran's Teaching Incentives; and 90, Parent Involvement in Education; to oppose HB09-1009, Require Public School Emergency Drills; 1151, Oversight School Building Inspections; and SB09-29, Safety Belt School Bus; and to monitor all other pending legislation, in particular HB09-1057, Parental Leave Academic Activities; 1082, Recordings of BOE Public Meetings; 1087, Child Sex Offense Civil Actions Accrual; 1125 Limit Incentives for School Attendance; and SB09-33, Early Childhood Education Services Free Lunch; 46, Healthy Snacks in Schools; 57, Public School Financial Transparency; 89, State Charter School Institute.
