I. **Introductions and Housekeeping**

A. Chris Paschke, executive director information security and data governance, started the meeting with introductions at 4:33 PM. B. Panorama Education is contracted for one year with Jeffco Public Schools to develop surveys and create a process where they can normalize the data and allow us to track progress against peer districts. The dashboards that are created will allow educators to obtain useful information. The slide presentation includes links to contracts, vetting forms and the Panorama privacy site for those interested reviewing. The Assessment team was very purposeful and very restrictive on what kind of data they shared with Panorama. It was asked of the committee their thoughts around the potential of expansion of categories to include ethnicity or programming such as English Language Learners or Special Education. The Assessment team will follow up with answers to these concerns at an upcoming meeting.

### III. Data Ecosystem Update

A. Ms. Eaton presented the committee with an update around the data ecosystem. Her team is focusing on our learners and our future part of the Jeffco Thrives 2025 strategic plan. The objectives are to make sure students are on track with their learning in each of the four areas, elementary reading, elementary math, middle school math, and high school PWR standards to help the drop out or not graduating on time for students. This will be done in two phases of data sharing. Phase one will include current school year data like student demographics, test scores, attendance, course completion, grades and behavior. Phase two will include longitudinal data for the data modeling like multi-year student demographics, or matched cohort data from phase one.
